

Shortly after Warner graduated from the University of SD he began a distinguished 22 year career with the United States Secret Service. In just the third issue of the O&B, on July 8, 2009, Warner allowed me to publish a story on his absolutely fascinating and intriguing career

with the Secret Service. Since the number of O&B subscribers has increased by about 1,400% since Warner's story appeared I am running it again following his NASCAR adventure for all of you who missed it. O&B Editor

Jack,

In April 2013, I participated in the Nascar Experience, a Christmas gift from my son and daughter-in law. The Nascar Experience takes place at the Phoenix International Raceway, a 1 mile racetrack, which hosts a Nascar race twice a year in phoenix.



After a one hour drivers meeting, we were all assigned a race car to drive a few laps. All the cars are real Nascars with high horsepower and RPM limits. The track is one mile with a front stretch of 1179 feet and the dogleg backstretch at 1551 feet. So you are constantly accelerating



and decelerating but I was in continuous radio contact with a track spotter to go and slow. The turns 1 and 2 are banked at 10-12 degrees and turns 3 and 4 are at 8-9 degrees. My top speed was at 120-25. I drove 8 laps. Not bad for a 76 year old.

Also, **Karen**, my son and daughter in law and grandchildren were watching from Pit Row. Great Time !!!!

After graduating from South Dakota University in 1960, I worked with my Dad in a small oil distributing company in Sioux Falls. I was interested in federal law enforcement and after passing the entrance exam and extensive background check, I entered the U.S. Secret Service in 1965 in the Oklahoma City field office. The USSS has field offices in every major U.S. city. It was then a division of the Treasury Department and created in 1865 to suppress the counterfeiting of our currency. Subsequently, protection


became the primary responsibility of USSS. This was later extended to former Presidents and their spouses, visiting heads of state and serious candidates for the U.S. presidency. Additional duties of the USSS field offices are investigations of forged US Treasure checks, bonds and other security obligations of the United States. During my first year, I worked criminal cases with senior agents and attended 3 six week training schools. From 1966-1970, I was assigned to the Presidential Protection Division at the White House during the administrations of Presidents Johnson and Nixon.

In 1970, I was transferred to the Dallas field office and in 1974; I became resident agent of the Lubbock, Texas office. During my 8 years in Texas, I worked criminal investigations and many times was temporarily assigned to protective

details of the President, Vice President, foreign dignitaries and presidential candidates during election campaigns. In 1978, I was reassigned to the former President

as Assistant Agent in
charge and traveled
extensively with him for
seven years. In 1986

seven years. In 1986, I was transferred to our Los Angeles field office as Assistant to the Special Agent in Charge. It is the second largest field office in the US Secret Service and is comprised of several investigative units. I was in charge of one of the squads until my retirement in 1987.

In 22 years with the Secret Service, I traveled in physical protection and conducted advance surveys for our protectees both domestically and in Europe, Middle East, Africa, Asia, Australia and South America. In total, I worked about twelve years in protection and ten years in criminal investigation.

Needless to say, we had incredible experiences over 22 years. At the time, I didn't give it a lot of thought as we all did what we were trained for but now I realize it was a crucial and sometime turbulent time in our history. Through it all, my wife Karen, (Gurley) and I raised 3 great sons and she carried on taking good care of us all. I have many former agent friends throughout the U.S. and I'm especially proud and privileged to have been a part of the US Secret Service.

After retiring on a Friday, I started the following Monday in 1987, to embark on an 11 year career with Master Card International concerning credit card

fraud. Previously, I had some experiences in card fraud as the Secret Service added a new federal jurisdiction regarding credit card fraud in 1984. I retired from Master Card International in 1998 as Vice President of Security and Risk Management in San Ramon, California. It was a great company to be associated with and I have been fortunate to have had two great careers.

RAYMOND JOHN "BUCKY" HEYER, 75, of Marion, SD, passed away in his home on Thursday, May 23, 2013. He was born in St. Paul, MN to Mary Charlotte and Jack Heyer. Bucky was raised on the east side

of Sioux Falls where he enjoyed playing baseball and eventually attended Cathedral High

School.

At Cathedral, he was named class president as well as played first string basketball and baseball. From there, he attended college at the University of South Dakota where he earned a B.A. in political science, played first string baseball and basketball and was a member of the Delta Tau Delta fraternity. While in college, Bucky bought his first business: Tiki Liquor. Tiki Liquor was only the start of his long list of

business achievements. In 1967, he opened the Mocamba Club, whose opening act was The Big Thing (now known as Chicago). He later built the state's number one bar and restaurant, The Fireside Lounge, located in the old Western Mall. But his accomplishments weren't limited to the alcohol/bar industry.



During his decades as an entrepreneur, he created "Deals on Wheels" magazine; organized the group that later went on to develop the Empire East Mall;

served as the only auctioneer in Maui, Hawaii; created a women's line of clothing called Bucky's Calamity Jeans; and created/owned Tea Realty, which was responsible for bringing millions of dollars in business to Tea, SD by way of new restaurants, grocery, hardware and drug stores. Professional honors and distinctions earned include serving in the Marine Corp, being honorably discharged from the Army where he served in Germany; being elected president of the Retail Liquor Association; being appointed State Director of Alcohol; receiving a Key Man license from the South Dakota Gaming Commission; and graduating from Reich World Wide College of Auctioneering from which he earned the designation of "Colonel".

Bucky's favorite pastimes were playing poker, giving his cat, Dipper, rubdowns, fishing, flying, sports, debating politics and taking long walks with his dogs on their beautiful acreage. He had a deep appreciation for wildlife, good food and telling jokes. And he will be remembered for his lively stories told around the poker table and his many commercial contributions to the Greater Sioux Falls area.

He is survived by his wife, Susan Heyer; his daughter, Jill Freeze of Ellensburg, WA; his grandson, Christopher Freeze of Bellingham, WA; his granddaughter, Samantha Freeze of Ellensburg, WA; his mother, Mary Charlotte Heyer; his sisters, Rose Dougherty, Marsha Heyer and Greta Carter; and his brother, Stuart Heyer. Bucky was preceded in death by his father and sister, Jeannie Johnson.

In lieu of a traditional service, it was Bucky's wishes that he be cremated and then scattered along his acreage driveway along with the ashes of his dogs, Pretty Girl and Sausage.

Unfortunately, I didn't have access to any Cathedral yearbooks, but then I remembered Duane's offer of help.

I called Duane and told him what I needed and he didn't even question my request. He just asked, "Will tomorrow be soon enough?" Sure enough, in less than 24 hours Duane located a 1955 Cathedral Yearbook, went to Kinko's to have Bucky's photo scanned and emailed it to me, thus allowing me to publish Bucky's obituary in its entirety. Thank you so very much Duane.

After all of Duane's help I wanted to know more about him and requested he send me a story and photo of him self. I am most happy to print Duane's story below. I am also very honored to print below his story the Military Memorial on Duane's older brother, **Gene O'Connell CHS '49**.

Matson and she is originally from the East Iron Range of No. Minnesota. I grew up in the North End (Sioux Falls all my life) I worked at Morrell's for 23 yrs. (laborer) and when we had a strike in '87 I figured it was time to move on so I went to work at McKennan Hospital where I cleaned the operating rooms for 20 yrs. I retired in 08.

I was single until I was 33. Us Irish Micks like to stay home with our Mother's as

long as we can! Iol. I was married for 15 years and divorced in 91. I met Barb in 93 and in Oct. it will be 20 yrs. She has been good for me. She had been married for almost 25 yrs. so neither one of us want to do that again. She is only 63 and is still working as a Med Aid at a nursing home

here. I come from a family of 9 kids. I am the youngest and the only one surviving. I had Twin brothers who were the next to me in age by 9 yrs. they were Jim and Joe and graduated from CHS in '52. I had a brother Gene who was killed in the Navy in '53. Sixty years next week! He was 23 when he died and worked at the Argus before entering the Navy. I was a last chance baby as

my Mother was 45 and my Father was 49. Mom lived to be 93 and my Dad was only 61.

I will send you the memorial (Korean War) of Gene. I was about to turn 10 when he died but we were very close. After 60 years I still feel I'm close with him.

Jack, it would be nice to meet and that leads me to the year of '14 which would be your 60th Class Reunion correct? I hope to be here. Many years ago (60-61 era) I played softball with Pat Smith. I really liked the guy. I remember giving him a ride out to the Ramkota from Nusier Salem's pub in 74 to his 20 year reunion! He probably would not remember me now. It's crazy how I remember that stuff. I couldn't remember what the nuns taught me!!!

I did not think Bucky's pic was very clear Jack, I hope you can brighten it up a bit. Keep up the good stuff you are doing and keep in touch. (anytime) Wow, I have rattled!

In Memory of U.S. Naval Seaman

Eugene Francis O'Connell

Sioux Falls, South Dakota Minnehaha County

January 28, 1930 – June 9, 1953
Died of Injuries while Serving Aboard the *USS Lipon*, Yokosuka, Japan



Eugene "Gene" Francis O'Connell was born on January 28, 1930, in Sioux Falls, South Dakota, to John J. O'Connell and Marie H. O'Connell. Eugene had eight siblings; his brothers were Ralph, John Jr., Joseph, James, Duane, and his sisters were Lucille, Ruth, and Helen. He lived in Sioux Falls all of his life, where he attended schools and graduated from Sioux Falls Cathedral High School in 1949. Eugene is remembered as being quiet, strong and handsome with "movie star looks." He loved to help people and was a friend to all who knew him. He was also interested and enjoyed all types of sports, including baseball, where he once pitched a one-hit game in a local league game in Sioux Falls. Before he entered the service, he worked for the *Argus Leader* in Sioux Falls while a member of the Naval Reserve.

Eugene was activated and trained in San Diego, and was then assigned duty to the *USS Uvalde*. Although he shipped out for duty overseas in the fall of 1950, he returned to the States every three or four months as the *USS Uvalde* returned for supplies. His last letter home was dated April 28 [1953], and was written home with stationery from the *USS Uvalde*. It read, in part:

We arrived yesterday, was very happy to get your letter. Most happy to hear Dad's X ray shows improvement.

About 10 minutes before we left Oakland, we had a fire on the ship. It wasn't big at all. But we had a big send off with about 6 fire trucks there. It was quite warm all the way across. The best trip we have had yet. We are in Yokosuka now, we are leaving for [unreadable] tomorrow....

At some point prior to his death, Seaman O'Connell was transferred to duty aboard the *USS Lipon*, a tugboat. At Christmas-time of 1952, Seaman O'Connell was home on leave for the last time.

On June 8, 1953, while working on the *USS Lipon* near Yokosuka, Japan, Seaman Eugene O'Connell fell about 25 feet into a concrete drainage area and suffered a fractured skull and severe neck injuries. According to his family, he lived until the next day and died on June 9, 1953, in a Naval Hospital in Yokosuka, the same day his family was informed of his death by a telegram. He was 23 years old. His brother, Duane, remembers that Eugene's death had a great impact on him as he was only eleven at the time. He wrote of his brother, "We were very close as I idolized him and followed him around when he would come home on leave. Hence he called me 'Shadow' for following in his tracks whenever I could."

Eugene's body was kept in cold storage and was shipped home for his funeral in Sioux Falls on July 15, 1953, at St. Joseph's Cathedral. The family was able to view Eugene's body through the hermetically-sealed glass covered coffin. They were comforted to be able to see him before burial; his brother said, "At least we knew we had him back." He was buried with full military honors at St. Michael's Cemetery.

Eugene O'Connell was awarded the National Defense Service Medal for his service to his country.

Currently only Eugene's brother, Duane, survives him.

Although I am not home much anymore, I still live at Buffalo Ridge West of Sioux Falls.

While still a student at WHS, I joined the S. D. AIR NATIONAL GUARD. I first met General Joe Foss

while serving as his cook at the Air Force Base in Alpena Michigan. He later became S.D. Governor and the first American Football League Commissioner. Later i was asked to serve as a member of the JOE FOSS FOUNDATION which sponsored seminars in schools nationwide.

In June after our 1956 WHS graduation, I bought my first restaurant at age 17, then a drive in at 18 and then at 19 built the JOKER, a night club on West 12th Street.

Sold them all, and at age 20 married Barb Fitzgerald, Class of '58, who I had met at the Cottage Drive In when she was 13 and a car hop and I was 15 and a fry cook. We were married 25 years and now have 13 Grandchildren & 4 Great Grandchildren. I have been with Diane every since my divorce.

Now that I am older, I finally wrote an article about my birth and divine intervention. Now everyone will understand

why I have been blessed by God since the day I was born.

After getting married, I started South Dakota Fireworks, Inc which grew into a fairly large company nationally plus having 17 warehouse stores. After 25 years sold to Rich Bros. I then went on to start the Traveler Magazine (now run by son) and also World Famous Black Hills Gold which at its peak had 880 retail accounts nationally plus some retail showroom stores.

Politically I first ran for the legislature at age 29 and elected as one of the youngest ever. Then voted FRESHMAN LEGISLATOR OF THE YEAR. I served most years from 70 to 88 finishing after eight years as the Senator for Sioux Falls. My image was I was the one who successfully helped keep the state income tax out of South Dakota.

I helped them on many projects. (Such as getting Congressional approval to sell AWACS planes in the Middle East) I was the last political person to see the President before he died. I was doing a presentation at his library in Simi Valley, he was having a good day, so the Secret Service brought him up to the library and we got to spend some GREAT time together. I was the last and Bob Hope and Bob Dole were the last two before me too see him.

In the 80's I helped high profile attorney, Gloria Allred, in her program In California to find DEAD BEAT DADS. This was announced nationally on the TODAY SHOW. I provided and paid for all the printed materials including window signs for California businesses and bumper stickers for statewide distribution.

Like I said before, I have had a very blessed life. I have worked in most countries in Asia and all of Europe from Slovakia in the east to Iceland in the west. (Many countries many times).

I am still doing International Advisory work. I just finished advising in the Presidential Race in the Congo (We got 63% of the vote on first ballot in 13 man race). Last week we got a contract approved in Moscow to build a chain store across Russia. I am presently working PRO BONO with a close Governor friend of mine on a probable huge theft of money from USA TO LONDON & SCOTLAND.

We want to retrieve it and apply it to our 16 Trillion national debt.

I must tell you of my proudest community service moments. Over the years I have produced

hundreds of concerts with the biggest stars in the music world. who over the years many became good friends of mine. I also became a voting member of THE ACADEMY OF COUNTRY MUSIC and still attend the award show on CBS every year. When the State Fair went bankrupt, Governor Janklow asked me to go to Huron, pull my magic with my friends and save the State Fair. Wayne Newton donated his time and we paid orchestra expenses. Rick Springfield, at the height of his career, agreed to come to our

little fair in SD. This next one you will

not believe. My good friend Johnny Cash came Pro Bono which really helped us become solvent in one year. We received world wide press from this. After Johnny Cash died, Bill Janklow told me we should have named the grandstand after him for what he did for South Dakota.

I received national publicity during the Carter Administration when I helped lead the fight against OPEC. Gas was rationed (20 gal),the price skyrocketed, lines at all gas stations and then most of them would run out of fuel. I originated the national slogan, A BUSHEL OF GRAIN FOR A BARREL OF OIL as we are the worlds bread basket. President Carter and Congress used this repeatedly. David Brooder of the WASHING POST first wrote a big article about me and my project. Then Newsweek Time Magazine and U. S. News also wrote feature stories on me and my project. This story was also used in most every large daily newspaper in the country.

I spend the balance of my time (about three months a year), in Cabo San Lucas (2 to 3 weeks at a time).
